One of the most important meetings in the village took place in October in the main hall of our school. Around 250 people came to hear progress reports on our two by passes including the Deputy Mayor of the Borough of Tunbridge Wells, Councillor Blakway. The meeting was called by the Parish council in conjunction with the 2000 Committee and the By pass Campaign Committee and it was standing room only.

Parishioners heard that the B2015 By pass should be started in 1981 and comment largely centred on the way the County Council proposed to "cross" Church Road. Numerous alternatives to the proposed closing of the lower end of this road were voiced and these suggestions have now been passed on by the Parish Council.

Our MP gave a brief account of his efforts in Parliament - reported elsewhere in this newsletter - to pin the Minister of Transport down to a starting date for the A21 By pass. This is now 1984. He closed with a strong appeal to the village to keep up their pressure on the Minister to maintain his promise.

# The tree of life

The title of this article on trees is not so strange as it might at first seem. They provide life to us - yes Homo sapiens, receive life-giving oxygen from trees and it is a by-product of an enormous energy chain that is going on all around us every day and we provide them with a raw material - Carbon Dioxide.

The green chlorophyll in the leaves absorbs the carbon dioxide with minerals drawn from the tree's roots, produces Carbo-Hydrates and Oxygen by Photo-synthesis with the sunlight. Symbiosis or total interdependence describes how we depend on trees and them on us, but the harmony has gradually been destroyed and it started in the Wealden area of Kent when the first large fleets of Wooden Ships were built in the 15th and 16th centuries. Since that time various man made disasters have befallen trees and some natural ones too - like the most recent - Dutch Elm disease. The Clay Vales used to be saturated with Oak Forests but farming has tended to remove them one by one. The Elm has virtually gone, many other once indigenous varieties have disappeared, but we constantly ignore the need to replace and conserve what we have got.

Trees also provide real beauty and homes for all kinds of animals, birds and insects as well as other plants.

Pembury is lucky in having some very fine trees but they are old and the younger ones are often removed due to development of land. "So plant more trees" and make them deciduous. Not all evergreen or conifers. The new developments in particular need more trees to furnish them with beautiful displays during the summer months.

The cost is not great but the effect can be enormous. In my next article I will describe suitable types of plants and their cost.

## **PLANNING APPLICATIONS AND THE POWERS OF THE PARISH COUNCIL**

An earlier edition of the News letter referred in passing to the Powers of your Parish Council in regard to Planning Applications for alterations to property within the Village. During this year the Parish Council has been discussing with the Borough Council the possibility of it becoming involved more directly in the decisions on individual applications.

The legal position at the moment is quite clear. The Borough Council are the elected body with the power to decide applications for Planning Permission. Your Parish Council is sent copies of each planning application when it is received at the Dower House but its only function is to comment on the application and send these observations to the Borough Council.

This whole matter is quite understandably a very confusing one for the layman to understand and the purpose of this article is to explain as simply as possible to readers the situation as it exists and what the Parish Council have been trying to do about it.

The Parish Council have become increasingly concerned at some of the decisions being given by the Borough Council on Planning Applications which in some cases are completely contrary to the Parish's recommendations.

A series of meetings has therefore been held with officials and councillors at the Dower House and this ended with a meeting with the full Borough Council Planning Committee and representatives of the Parish Council.

Three requests were made at this meeting:

1. That the Chairman of the Parish Council or his appointed Deputy be allowed to attend Borough Council Planning Committee Meetings and speak on Planning Applications in Pembury, therefore ensuring that the Parish Council's views are properly conveyed.
2. That all applications for residential planning approval larger than say two or three houses at any one time, are refused by the Borough Council on the basis that the Village has already had quite enough new development for the time being. (This request reflects the wishes of the Village set down in the Study 'Pembury 2000')

3. That a Local Plan be prepared as quickly as possible by the Borough Council Planning Officer to give legal force to the recommendations of 'Pembury 2000'.

**All three requests were rejected by the Borough Council Planning Committee and received no support from the Member of the Borough Council who represents Pembury on the Planning Committee.**

After this meeting, however, the Pembury Borough Councillor has subsequently agreed to put the recommendations of the Parish Council on Planning Applications to the Borough Council Planning Committee.

Your Parish Council is therefore in a very difficult and largely impossible position. On the one hand it is not allowed any real power in deciding applications but nevertheless it is the elected Local Authority for the Village and one to whom Parishioners should quite correctly look for guidance, direction and advise on matters of Planning.

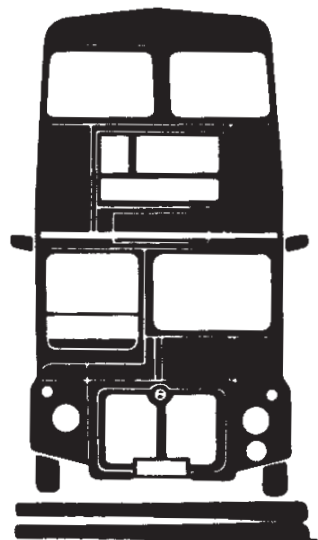
All that can be said in summary is that if you feel aggrieved on a Planning Application then please involve your Parish Council and if it is possible for them to give you any help then they most certainly will.

# Parliament

In the early hours of the morning of 12 July our by-pass to the A21 formed the subject of a special debate in the House of Commons. Our Member of Parliament, Mr Patrick Mayhew, rose at 1.26 am to put to the Minister the continuing delay with the completion of the by-pass and the waste of money with the re-investigation of different ways of by-passing the village.

The debate resulted from a meeting between our M.P. and our Parish Council and By-pass Campaign Committee. The particular form it took meant that the Minister was compelled to give a full reply and as specific an undertaking as he possibly could. Mr Mayhew went through the history of the scheme and this does not need re-stating now.

With the benefit of the information supplied to him by the By-pass Campaign Committee, the Parish Council and the Pembury 2000 Action Committee he pressed the Minister very hard to say why the A21 by-pass was not the **right road in the right place to the right standards and at the right time.** "The **right time**: try telling Pembury that this is not the right time and one risks getting a declaration of UD! with all the traffic halted at the frontiers. Pembury has had more than enough of the dangers to life and limb presented by the traffic passing through its centre. It was the right time 44 years ago and it has not stopped being the right time ever since.

It is against this background and these principles that the current procedures of the Department of Transport regarding the Pembury by-pass fail to be judged. The Department is solemnly insisting on going through the same preliminary report procedure that would be appropriate if the Minister were suddenly to wake up one morning and say "Let us build a spaghetti junction over Canterbury Cathedral".

Who is the Department asking to prepare that report, with all its investigation of alternative layouts, estimates and technical reports, deposit periods, exhibition periods and assessment reports? None other than the Kent County Council. As a result the Minister is not scheduled - I have the schedule here - to adopt the preferred line until a period beginning on 14 May and ending on 6 August, 1979 .....

Why does not the Minister come to Pembury, or to Tunbridge Wells hold a public meeting, say that he wants to avoid unnecessary waste of time, explain that the Southern route seems to him to be the only possible one, but that he will listen to other views then and there and invite any objectors to come and visit him in London .....

Two steps are now urgently needed, first the Minister should, perhaps after a meeting of the type that I have suggested, adopt the southern route as the preferred route, relying upon what everybody in the district has known for donkeys years. Secondly, the Minister should not muck about; he should say that this one mile construction should be of dual carriageway standard."

**The Minister, Mr John Horam**, who at present is the Under Secretary of State for Transport, rose at 1.38 am to answer Mr Mayhew. It is pleasant to be able to report that he gave a very full reply. Unfortunately the very fullness prevents the whole of it being reported in our Newsletter but the following are extracts and the full report is available from the Editor for anybody interested (Hansard, House of Commons official report, volume 953 No. 152 for Wednesday 12 July 1978. Price 40p "No-one disputes that Pembury needs a by-pass ..... In addition, as the Honourable and learned gentleman pointed out, there is not one problem at Pembury, but two. The second arises from the B2015, ..... therefore Pembury does not need one but two by-passes, the second being the responsibility of the Kent County Council.

He (Mr Mayhew) has put down Questions and written me numerous letters as have many of his constituents. I am thinking particularly of the Pembury 2000 Action Committee, which is very active. We have also had a petition from parishoners of Pembury”.

**The Minister** then went on to set out the programme from July 1977 - 1985 which has already been fully reported in previous issues of the Newsletter. He continued by saying that the 8 year time table instead of the normal 10 indicated the importance and priority he attached to completing the Pembury by-pass and he answered Mr Mayhew’s particular question about duplication of work and consequent waste of money.

**The Minister** insisted that there was no duplication add that the work already done by the Kent County Council was of a very preliminary nature. They were now carrying on with that work in their capacity as agents for his Department. However, Mr Horam was not able to give any denial that the Department were not investigating a northern route for the by-pass.

**The Minister** continued “Let me give the Honourable and Learned Member a commitment. I understand the frustration when so many people want this by-pass. If we find - we can ascertain this shortly now because of the work done between the middle of last year and now - that the northern route is not an alternative at all, we can short-circuit the procedure of public consultation. I am anxious to do so. I have said many times that I see no point in an elaborate public consultation procedures when only one effective route is possible.

Nevertheless, under the procedures laid down by the Honourable and Learned Members own party in 1973 we have to have some public consultation of the most skeletal kind. I will ask my officials to publish the fact that they have come to this conclusion and invite anyone to comment on it but conduct no further investigations.

That could save about six months and we should then probably be talking about doing that in the early part of next year. By the end of 1979 we should have it fairly well programmed. It will then take about eighteen months to two years to work it up in a detail design stage with all the engineering consequences. The enquiry should take place in 1982 with a start in 1983 and finish in 1985. That is rather tight, with little room for slippage, but that is the sort of time we could finish in.

It would not have been done any faster by the County Council. I understand from a publication by the Pembury 2000 Action Committee that the Council said that it would come after the Bluebell Hill by-pass in Rochester was completed, which under Kent's current transportation programme will be finished in 1981/82. The means that even if the Council went ahead as planned - and I doubt whether they would be able to achieve that they could not start by 1983. With the funds available, I think we should be able to start this sooner than Kent could have done it had it remained a County Council responsibility. At the end of the day the people of Pembury will be getting their by-pass sooner than the average time and sooner than if Kent had remained in charge, simply because the Council would have lacked the financial resources."

## **VANDALISM**



The Parish Council estimate of £500 a year lost to vandals has had to be altered. New doors to the Recreation Ground Pavilion have been damaged within days of being fitted — did you see those responsible for this senseless damage?

It is to be presumed that the answer to this question in most cases would be 'Yes', but this general question has a very important reason lying behind it at the current time.

A National Review of Local Parish Boundaries is now under way and a duty has been laid by Parliament on the District Councils throughout the Country (in our case the Tunbridge Wells Borough Council) to examine the existing Parishes and to suggest any alterations to particular properties or land within them. The Tunbridge Wells Borough Council also has to consider the setting up of new Parishes but clearly this does not apply in the case of Pembury.

Your Parish Council have suggested, when they were consulted by the Borough in the Summer, that consideration could be given to alterations in the area of Amhurst Bank, Colts Hill, Dundale, and the Cornford Close Cornford Lane, Tonbridge Road area.

The overriding concern of the Parish Council in this matter is to only suggest alterations when these would bring improvements and would also recognise the fact that an individual householder usually feels part of one community or another.

A good case in point is the area of Cornford Close and Cornford Lane and the southern side of Tonbridge Road up to the Fairthorne Garage.

The Boundary between us and Tunbridge Wells is at the moment most strangely drawn. It excludes houses and house owners who it would be thought would quite clearly consider themselves part of our community and the Parish Council has therefore suggested that the Boundaries could perhaps be re-drawn in this area.

This would have the effect of including Cornford Close and part of Cornford Lane and the properties such as Colebrooke within the Parish.

If you feel strongly about this suggestion or live in one of the other areas referred to above then the Clerk to the Parish Council would be very pleased to hear from you (16 The Coppice, Pembury 3459)

# **ROYAL BRITISH LEGION – Pembury Branch**

Formed about 1929, operating now with about 50 members, the Executive Committee of the Branch meets each month at the home of the Chairman, Mr John Young of 13 Bulls Place. Mr Young is also the Branch Standard Bearer and Membership Secretary, and for several years he was the County Bearer. His wife, Mrs Irene Young, is the Womens Section County Bearer.

Legion Membership is basically for people who have served in His or Her Majesties Forces, or in the Merchantile Marine who have served afloat during hostilities, and members of the Red Cross Organisations who have served with the forces of the Crown. There is Associate Membership for adults who have not served, but who support the aims and objects of the 'Legion'.

The aims are to promote the welfare by charitable means, of the Ex-service people, their widows and dependants.

The Annual Poppy Appeal is the means of raising most of the money needed for this, some three million pounds or so.

In Pembury the Branch run the appeal with Mr Alan Mitchell of Beckwith, Langton Green, as the actual organiser. He is also the Branch Secretary.

The village collection for the year ending 31.5.78 was £422.16 an increase of £82 on the year before. There are some 21 House to House collectors, and more could usefully be absorbed to share the load. Shops, Offices, Schools and the Hospital also have collecting boxes and poppies.

Consideration is now being given to starting a Branch of the Women's Section of the 'Legion' within Pembury. The aims and objects are similar, but the members need not be Ex-service themselves, but they have to be within a maximum of grand-daughter relationship to an Ex-service person. The national organisation of the Women's Section is quite separate, but the work is complimentary and the twin Branches work together in many ways.

The annual Remembrance Parade and Service is held at the Upper Church of St. Peter, by kind invitation of the Vicar with a 10.45 am assembly each year on Remembrance Sunday which always follows the Poppy Appeal period. Ex-service people would be most welcome to join the Parade and Services and also the Branch. The Branch Subscription is under £1 per year both for Ordinary and Associate members.

The Branch Service Committee is responsible for administering any "Service" or Benevolent work needed in the village, with help as necessary from the "Legion" organisation nationally.
