# VIEWPOINT

# REFLECTIONS from the chair

Did you enjoy your first year as Chairman of the Parish Council? I have just been re-elected Chairman for the present year and was recently asked this question.

After the election in May 1979, 13 people elected as Parish Councillors some of whom had been on the previous Council met together for the first time. Previous and newly elected Councillors alike were appointed on to the various committees and I was nominated and elected Chairman and we have all completed our first year. It is difficult to say whether or not it is a job that we enjoy. There are so many different things going on all the time apart from the Council meetings which seem at times to go on forever - and by 11.00 pm - after hours of discussion we try to reach some sort of decision. I think that each of us has to become a specialist in one subject or another affecting Parish life; and we are lucky to have some specialists who can give advice; for example Bob Allen, ex Kent Messenger, who is dealing with the publication of the Parish Guide: Arthur Bromwich, Banker, advises on financial matters and Derek Richards who Hawes assists on planning advice.

For the newer members it has been

difficult to catch up with history for much of what happens at the moment is based upon subjects that have been discussed over years i.e. community centres, gypsies, planning applications and appeals and the never ending saga of the by-passes. At times being on the Parish Council is rather like bashing your head against a brick wall, but there are always successes which add light i.e. the work being done on the Village Hall and improvements to the Recreation Ground and Woodside Playing Fields and the current proposals for the by-passes, Despite the minor disagreements, the members of the Parish Council work well together, enjoy the contributions they each make and welcome the odd controversial natter now and again so they can each air their own views.

The last year for me has been interesting, a challenge and thoroughly enjoyable — despite the long meetings. I have met a lot of people both in and out of Pembury and was flattered to hear recently from a Tunbridge Wells resident the opinion that Pembury was a strong community. If that is the impression that is given to the outside world, long may it continue and I hope that the Parish Council will function as constructively and as successfully in its work this year.



### News from PEMBURY Chest

Preparations are now well forward for the Village Fete on July 12th. The Fete will be opened on the Recreation Ground in Lower Green Road at 2pm by Mrs. Sarah Clarke, Chairman of the Parish Council.

It is planned for Mrs. Clarke to arrive on the ground in style. Prior to the opening of the Fete she will go to the Village Green to meet entrants in the Children's Fancy Dress competition and will then head a procession of contestants, travelling in a vintage Rolls Royce kindly lent



for the occasion by Mr. Ivor Bramley of Pembury Hall.

In addition to the usual number of stalls and side shows, there will be a display by Paddock Wood Judo Club with a running commentary by their Black Belt Instructor — a band interlude by the Band of the Christ Church Scout Group from Tunbridge Wells making their third successive appearance at the Fete, and a tug-of-war contest.

A number of competitions for children and adults are being organised in connection with the Fete and entries for these will be displayed in the large marquee which will also house the tea room. During the afternoon tickets will be on sale for the Grand Draw for Premium Bond vouchers worth £25, £15 and £10.

The Wellgrove Riding School of Pembury is again providing pony rides and an innovation this year is the appearance of Punch, a magnificent Shire Horse whose owner, Mr. N. M. Westacott, will take the reins as he gives rides to children and adults in a genuine farm waggon.

Many Pembury organisations and individuals are helping in putting on the Fete and we are hoping for a fine day and bumper support as a reward for their efforts.

This year the Pembury Chest Committee decided to allocate the profits from the Fete to help with the refurbishing of the Village Hall, which is at present undergoing alterations. With constantly rising costs it is unlikely that the Parish Council will have sufficient money to pay for complete redecoration as well as the alterations now in hand. The Committee felt that as the hall is used by the majority of residents at some time or other it was a worthy cause for which to hold the Fete.

This does not rule out the probability that the Chest will return to its former policy of distributing its surplus to deserving Village organisations in future years.

Programmes which act as admission tickets to the Fete, will be on sale from house to house shortly. Helping in this effort, in addition to members of the Chest Committee will be members of Pembury Conservatives and Pembury Horticultural Society to whom our grateful thanks are due.

Pembury School Parent-Teacher Association, which will hold its own Annual Fete on June 21st, will be represented at the Fete with a stall and the Chest will also run a stall at the P.T.A. Fete.

### THE PEMBURY SOCIETY



The Pembury Society is our local amenity society. Originally the Pembury Residents' Association, it was founded in 1972 by the late Cyril Masterman, a Pembury resident, because of the problems arising from the exceptionally rapid growth of Pembury at that time and the concern felt for its changing character. In the previous 15 years or so the village had developed far in excess of the official plan, the population trebled, and became dominated by the large intensive building projects by outside interests which seriously overstrained existing resources, particularly with regard to roads, schools, transport and other essential services, as well as our rural amenities. Many of these problems remain and there is continued pressure to destroy what many people have come to enjoy.

The aims of the Society are to secure the preservation, protection, development and improvement of features of special interest, to preserve the surrounding countryside (an essential part of Pembury), and to make known to the authorities concerned the feelings of local residents in the development and character of the village.

The Society is a member of the Kent Federation of Amenity Societies and the Committee for the Protection of Rural England (Kent Branch) and is registered with the Civic Trust. The Civic Trust has throughout the country over 1200 amenity societies or similar groups on its registers and is very influential in helping to preserve our national heritage of countryside and buildings and to resist spoliation by insensitive commercial exploitation.

The Society usually has two meetings a year, each with a talk by a specialist on some topic of local interest, and members are sent newsletters from time to time. Walks round the parish footpaths are arranged monthly. Members of the Committee regularly attend meetings of the Tunbridge Wells Borough Council Planning Committee, the Pembury Parish Council and the Pembury 2000 Committee, and all local planning applications are monitored and representations made to appropriate bodies as considered necessary.

The Society is completely independent and self-supporting, and membership is open to all residents or others with an interest in Pembury. The annual subscription is only 25p (Senior Citizens 10p) and the Membership Secretary is Mrs. B. May, 54 Romford Road (Tel: 2548). Why not join? The more who join, the greater the Society's influence in helping to keep Pembury as we would like it.

Mrs. Liz Caple, who organised the highly successful Christmas Mini-Market on December 1st, has resigned as Chairman of the Chest for personal reasons, but she will continue to help with activities. We shall miss her dedication and organising ability.

In her place we welcome a new chairman, Mr. Arthur Bromwich, who was elected a parish councillor last May and who is involved with a number of activities in the village.

### OUR BY-PASS'S



In view of the silence over the past few months on the current position with these two By-Passes the Parish Council at a recent meeting invited County Councillor, P. M. Heath and K.C.C. Roads Engineer, Mr. T. Hill to advise them as to progress.

#### B2015 By-Pass

The start date at the time of writing is Summer 1982 with completion at the end of 1983.

The planning application is at present awaiting determination by the County Council. It has had to be revised to allow for access to the West Kent Water Company's water gathering grounds in Pembury woods. This will not delay approval of the planning application by the Kent County Council's "Powers Subcommittee". Any comments that the Borough Council and Parish Council have on these revisions will be allowed for in the planning approval.

The next stage in the pre-contract work for the road is to issue the Compulsory Purchase Orders and the Side Road Orders and hopefully this will be complete for finance to be applied for from the Department of Transport in November 1981. This would then fix the road construction into the Kent County Council's 1982/1983 financial year.

#### A21 By-Pass

The small scale drawings that were on display at the Village Exhibition in January last year have now been revised and completed by the Kent County Council acting as Agents for the Department of Transport.

The formal recommendation of the County Council that there is only one practicable line for this By-Pass, and that therefore the normal procedures of studying an alternative line can be dispensed with, has now gone to the Department's Regional Controller at Guildford.

This formal recommendation has in turn been passed to the Department's Head Office in London and the Parish Council understand that a decision is connected directly with the White Paper on Road Construction Programmes which has been promised for the last six months but has not yet been published.

The Parish Council were unanimous in their feeling that the discussions had been extremely informative and that these must be maintained on a regular basis. Hopefully this would ensure that both By-Passes are kept to their current programme dates.

The Council agreed that a further Public Meeting should be held, hopefully early in November, so that a full report could be given to the Village. The meeting would be attended by our M.P. Mr. Patrick Mayhew and County Councillor Heath, in company with Mr. Hill the Engineer responsible for these two roads within the County Council.





COUNCILLOR A. J. E. BROMWICH

The Finance Committee of the Pembury Parish Council consists of all thirteen Members of the Council. Before 1975, the Committee consisted of five Members and like all other Committees met once a month in the house of the then existing Chairman, with the Clerk taking the minutes, which were presented to the full 13 Member Council which met every month to discuss matters all over again before any decision was made.

In an effort to make the Parish Council Committees more efficient the Parish Council agreed that the whole of the thirteen Members should meet in Public as Members of each of the Committees to stop duplication of work.

The Finance Committee meets every 6 weeks within the rota of Committee Meetings to deal with decisions that have to be made in the administration of Council's business and also to discuss or receive reports on any financial subjects that are likely to affect future plans. In addition every six weeks the thirteen Members have presented to them a Financial Statement showing the up-to-date position of the Parish Council, this statement includes details of all cheques to be paid by the Parish Council and these are all carefully scrutinised before payment is authorised.

In between the rota of Meetings, a sub-Committee of five Members deals with any day-to-day decisions as and when they arise, the five Members being the Finance Chairman, his Vice Chairman, the Chairman and Vice Chairman of the Parish Council and one other Member of Council.

In the autumn of each year, this sub-Committee with the aid of the Clerk will have the task of preparing a draft budget for the following financial year, usually in November, which is presented to the Parish Council's Policy and Resources Committee, a Committee made up of all the Council's Committee Chairmen, who will decide which projects can go ahead and how much money will have to be raised for them and the running costs of the Parish for the next financial year. The annual budget is then placed for final endorsement at a full meeting of the Parish Council where all members have the right to query any part of the accounts.

The main problem facing the Finance Committee is that it has to budget some 18 months ahead and must anticipate future costs and it is some measure of the members ability that from a £34,000 budget last year, the balance being carried over to this financial year is likely to be in the region of only £1,000 - £1,500.

Each year the accounts of the Parish Council are subject to audit and the Chairman of the Finance Committee and the Clerk have to attend the District Auditor to give information explanation and substantiate by resolution all the financial decisions taken during that past year.

You will appreciate therefore that the Finance Committee activities are monitored both inside and outside of the Council to a very great degree and this is as it should be as their decisions are in some way reflected in the Rate Demand that we each receive.

Amongst the various items on the Demand you will see "Parish Expenses" and a note made against Pembury's name. This year the parish rate is 8.4p in the £1—as a penny rate in Pembury produces £5,264, the required and estimated expenditure for this coming year is £44,744.

As has been said elsewhere one of the problems in Pembury so far as rates are concerned is that we have no industrial premises. In Paddock Wood for example last year a 1p rate produced £9,108, but in Pembury a 1p rate produced only £5,264.

On the basis that the average rateable value in Pembury is £250 then the cost to each house in Pembury—not to each person—is 41p per week. I hope you will agree that this represents good value for money.

# Village Hall - PROGRESS so far

In the latter part of 1978 discussions took place between the Pembury Parish Council and the Village Hall Management Committee on what could and should be done to improve and modernise the Village Hall and in particular the kitchen area which at present is very small and inadequate. Arising from these discussions came a decision to extend the building at the rear end by enlarging the existing kitchen. It was also noted that the main Hall was very shabby and in need of decoration. Your Council arranged for the necessary plans to be drawn and hoped for a quick completion. Unfortunately due to a number of problems, your Council had to abandon alterations at that end of the building and proceeded to look at and discuss the front end. Your Council and the Village Hall Management Committee met the Architect and discuss:

What was required and professionally what was able to be done. The following was decided upon.

- 1. The entrance to the Hall to be at the front, the side entrance to be a fire escape.
- 2. The front entrance to be modernised.
- 3. The toilet area to be modernised and to remain in its present position.
- 4. The entrance hall to be enlarged.
- 5. The existing bar to be demolished.
- 6. The chair store to be demolished.
- 7. To erect and furnish a new kitchen and bar at the front end of the Hall.
- 8. To decorate the interior of the Hall.

I am sure residents of Pembury will be pleased to note that finance is arranged, plans and planning permission have been approved and the building work has commenced. Your Council expects to continue with the interior decoration of the Hall as soon as possible after the Builder has completed his work, and I hope the result will give the Village a more modern and better equipped place in which to meet.



The Pembury Horticultural Society has been described as one of the most successful Societies in the Village. This success has been brought about by the constant hard work of the Committee over the past years and the interest of the Committee in the ever growing membership.

For a small yearly subscription of 50p for husband and wife (25p Senior Citizens) the various activities are open to all Members.

The Monthly Open Meetings held in the Village Hall on the last Thursday of the month are enjoyed not only by our own Members but by Members of another Pembury organisation and nearby local residents. The talks at these meetings, some illustrated, are given by selected speakers on subjects of which they are expert. Tea and biscuits after the raffle make an enjoyable evening.

The two Flower and Produce Shows held usually in July and September are well organised by our Show Secretary. The Shows give a chance to our Members to exhibit in the Summer Show sweet peas, roses, vegetables, various flowers, pot plants, floral art and cookery. The Autumn Show to exhibit dahlias, chrysanthemums, vegetables, various flowers, pot plants, floral art, cookery. The Shows are open to the public at 3pm on Saturday afternoon in the Village Hall.

One or two coach trips are arranged for members during the year, usually to visit a large Garden such as Wisley, Savill Garden, Syon Park, etc.

A service greatly appreciated by our Members is the Sunday morning opening between 10.00 and 12.00 noon of our Stock Shed on the Allotment site in Woodside Road. Two or three of our Committee give their time to serve our Members with a wide range of garden requisites at membership prices. At the same time our second shed is open for the Members to leave their bundles of waste paper for which we are grateful, as the proceeds help towards the cost of the various activities of the Society.

Last but by no means least, the Floral Art Group so ably run by our two demonstrators in the Village Hall on the second Monday of the month. For a fee of 30p any lady may take along her flowers and foliage, be instructed in flower arranging, have a cup of tea or coffee and a biscuit, also a raffle ticket — all inclusive. The Committee hope with the knowledge gained from the classes, members of the Group will enter the Floral Art classes in our shows.

#### PEMBURY PATCH Police Constable Brown

Here is a selection of unclaimed items of lost property handed in at Pembury Police Office during April and May.

A purse containing make-up, found in the High Street.

A Union key and key ring with a small blue torch attached, found in the woods behind the Lower Green Road Recreation Ground.

A set of car keys with a green leather key fob (believed to be for a Fiat), found near the Royal Oak.

A child's blue cardigan, found in Amberleaze Drive.

All road users are asked to note the following points. Doing so may well save a dent in the pocket as well as a dent in the car.

When parking your vehicle on the road at night please remember that it should not be within 15 yards of a junction without lights. Also it should not be parked at night on the offside of the road i.e. facing the wrong way — with or without lights, unless it is in a one-way street.

In general terms goods vehicles exceeding 30 cwt unladen weight should leave their sidelights on when standing in a road during the hours of darkness.

Riding a pedal cycle on the footpath may seem a trivial matter but it can lead to a serious accident, both for the cyclist as well as the innocent pedestrian. Observation shows that parents are just as thoughtless on this one as their children.

# YOUR CLERK REPORTS.....

The past three months have been busy for my Members — the most pressing matters being the problems over four of the Village Roads — Camden Avenue, Belfield Road, Canterbury Road and Henwood Green Road (near its junction with Lower Green Road). Most of the problems in the first three roads arise from indiscriminate car parking mostly inflicted by Parishioners on Residents as they seek to shop locally. As regards the first two roads my Members have themselves suggested solutions and these matters have been discussed at a recent Parish Council Meeting. As regards Canterbury Road the position is slightly different in that most of the parking is by Residents because of the lack of garages and because of this I have recently asked each Resident to suggest ways of overcoming these problems.

As regards Henwood Green Road my Council is acutely aware of the very dangerous hazards that exist on this Road, none more so than the Children walking to School. I understand from the Kent County Council that there are to be major road works to this part of the road between "The Royal Oak" and its junction with Romford Road which includes the laying of a new sewer and the construction of a footway, the latter will go a long way to alleviating the problems. I understand that these works are to take place towards the end of this year.

So much is the concern of my Members to all these problems that a meeting is to be arranged between the Highways Authorities, the Kent Police and the Parish Council so that the Parish Council's firm proposals can be placed before them and fully discussed. It is hoped that this meeting will take place around the time of the publication of this Newsletter.

Talking of problems, my Council is also fully aware of and are pressing the appropriate Authorities to ensure that the dangers inherent on the waste land behind "The Royal Oak" are abated as soon as ever possible and that the site can be fenced off without further delay. Another area where danger lurks, is the roadway entrance to the Roman Catholic Hall which to my Council's cappearn has been left in such an untidy and dangerous state.
